1. In accordance with the stipulations of the Bi-SC Procurement Directive 060-070 dated 30 June 2015, Annex C, the following information is provided on an Invitation for International Competitive Bidding (ICB) that this Headquarters has the intention to release.

Title of ICB : Provision of Office Supplies ACO wide

Requirement : The requirement is for the procurement of office supplies (stationery) for SHAPE located in Belgium and, possibly, other ACO Commands located in The Netherlands, Italy, Germany and United-Kingdom.

Type of contract : Fixed Price, Indefinite Delivery, Requirements type contract  
Requirement Contract

Period of performance : 01 January 2021 - 31 December 2021 with possibility to exercise up to 4 one-year options

Bidding procedure : Sealed Bidding (technical/financial) - Lowest technically compliant bid - the ACO electronic bidding portal will be used to compete this ICB (<https://aco.procureware.com>). **Firms not already registered on the portal are encouraged to apply for registration**

Eligibility : Governmental or Commercial entities (1) that originate and are chartered/incorporated within the 30 NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-member nations and (3) that provide the funding for the aforementioned requirement. Companies which have performed at least three contracts

within the last five years substantially similar in scope, complexity and magnitude to the requirement described in the solicitation
